- May be able to reduce cost, time.
- Application for Non-Profit Tax ID (EIN) Number

#### Non-Profit Best Practices

- Clear mission statement
- Set up a board.
- Craft bylaws
- Conflict of interest policy
- Entity structure (incorporate) & tax status (EIN & 501c)
- Develop annual budget and strategic plan.
- Create realistic fund-raising plan.
- Fundraising through a diversity of sources
- Keep stakeholders in the loop.
- Engage in annual self-assessment.

### **Business Best Practices**

- Choose a name: Google it and see if any other persons are using the name.
- Purchase a Domain name or see next 3 bullets.
  - 1) Choose an entity type: Corporation, Nonprofit Corporation or LLC (limited liability company). 501c3 is only a federal tax designation. In AZ, you would just form a corporation or a nonprofit corporation.
  - 2) Check name availability with the Arizona Corp Commission
  - 3) Secure the name or form the entity.
- File with the AZ Corp Commission, corporations division
- Obtain federal EIN or TIN
- Business Bank Account
